Section 3 – External Auditor’s Report and Certificate 2023/24

1 Respective responsibilities of the auditor and the authority

Our responsibility as auditors to complete a **limited assurance review** is set out by the National Audit Office (NAO). A limited assurance review is **not a full statutory audit**, it does not constitute an audit carried out in accordance with International Standards on Auditing (UK & Ireland) and hence it **does not** provide the same level of assurance that such an audit would. The UK Government has determined that a lower level of assurance than that provided by a full statutory audit is appropriate for those local public bodies with the lowest levels of spending.

Under a limited assurance review, the auditor is responsible for reviewing Sections 1 and 2 of the Annual Governance and Accountability Return in accordance with NAO Auditor Guidance Note 02 (AGN 02) as issued by the NAO on behalf of the Comptroller and Auditor General. AGN 02 is available from the NAO website – <https://www.nao.org.uk/code-audit-practice/guidance-and-information-for-auditors/>.

This authority is responsible for ensuring that its financial management is adequate and effective and that it has a sound system of internal control. The authority prepares an Annual Governance and Accountability Return in accordance with *Proper Practices* which:

- summarises the accounting records for the year ended 31 March 2024; and
- confirms and provides assurance on those matters that are relevant to our duties and responsibilities as external auditors.

2 External auditor’s limited assurance opinion 2023/24

Except for the matters reported below on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return, in our opinion the information in Sections 1 and 2 of the Annual Governance and Accountability Return is in accordance with *Proper Practices* and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

- The AGAR has not been signed in accordance with the Accounts and Audit Regulations 2015:
- Section 2 was not signed by the Responsible Finance Officer before approval.

Other matters not affecting our opinion which we draw to the attention of the authority:

In the prior year, the smaller authority was exempt from review, therefore we have not reviewed any evidence to support the prior year comparatives on the AGAR.

The smaller authority initially submitted a Form 3PM instead of a Form 3. As a parish council they cannot submit this form as it is specific to parish meetings. The smaller authority subsequently submitted the correct form.

The AGAR was not accurately completed before submission for review:

- Question 11a, 11b in the Accounting Statements and Assertion 9 in the Annual Governance Statement were left blank when originally submitted. The AGAR was returned for amendment and 11a and 11b have been correctly answered No and N/a, Assertion 9 has been correctly answered N/a.

The Internal auditor did not answer all of the recommended objectives to confirm compliance the relevant procedures and controls in operation were being achieved throughout the financial year as the following questions were not answered:

Test G: Salaries to employees and allowances paid to members were paid in accordance with this authority’s approvals and PAYE and NI requirements were properly applied.

The authority initially submitted the AGAR specifically for parish meetings and therefore there were certain tests the internal auditor would not have initially completed, this was one of those tests.
