- 6.1 <u>Cornwall Council Donna Latham</u> The Parish Council had received an update from Donna Latham on 21st December reporting that Cornwall Council had several discrepancies for Parish Councils in relation to Invoices from Biffa. The Parish Council have been strongly advised not to pay any monies to Biffa until issues have been resolved between Cornwall Council, Parish Councils and Biffa. Radar Speed Watch Congdons Shop - Further to the recent implementation of the 40mph speed restriction at Congdons Shop, Oliver Jones requested some speed monitoring to see its effect, the monitoring period has shown a good level of compliance, generally use the 85%ile speed reading which were 42mph in either direction, and only 1.5% (southbound) and 1.7% (northbound) of vehicles were in excess of 50mph, Oliver Jones suspects the Police would consider that this site was not a priority for any future enforcement.

The results would suggest that the previous reported issue of excessive speeding have been addressed someway with the implementation of the new 40mph limit, which has had a positive effect on vehicle speeds.

7. REVIEW OF CLERKS REPORT

- 7.1 <u>Camera's Village Hall</u> The Parish Clerk has received a response from Cornwall ALC, whom have sourced information from Andy Curtis of Newquay Town Council and his understanding is you can have public cctv in the proximity of play areas/play parks as part of a crime and disorder prevention and detection measure. However, this should be based on levels of crime in the area, be subject to a privacy impact assessment and ideally some public consultation/liaison with local police. Most important points is, cctv should only be monitored by trained and SIA licensed staff with robust policies and obviously the ICO registration. Therefore, Councillors have discussed this and feel that even though intentions are good, at this present time are unwilling to install and use CCTV.
- 7.2 <u>Grass Cutting Tender</u> Councillors wish the Tender to be placed in the Cornish and Devon Post and Cornish Times, to cover the areas of Play Area, Church Yard and Public Footpaths. Tenders to be discussed at the March Parish Council Meeting.
- 7.3 <u>Ralph Hudson New Councillor</u> All Councillors co-opted Mr Ralph Hudson onto the Parish Council as they believe he will be a great asset. Proposed 1st Cllr B Ruby 2nd Cllr A Parsons with all Councillors in favour.
